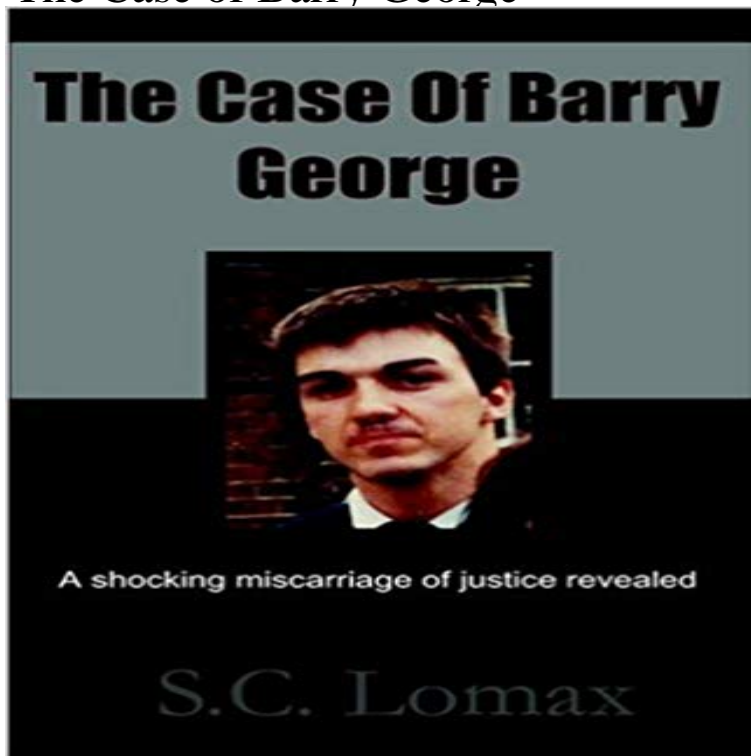


The Case of Barry George



In July 2001 Barry Michael George was convicted at the Old Bailey of murdering the television presenter Jill Dando. He was sentenced to life imprisonment, having been told that he was unpredictable and dangerous. The evidence against George was described as compelling, yet the case of Barry George remains one of the most controversial in British criminal history with a growing number of people believing him to be the victim of a miscarriage of justice. The Case of Barry George is the first book published which presents the facts and argues that Georges conviction is unsafe, with an innocent man incarcerated for a crime he could not possibly have committed.
