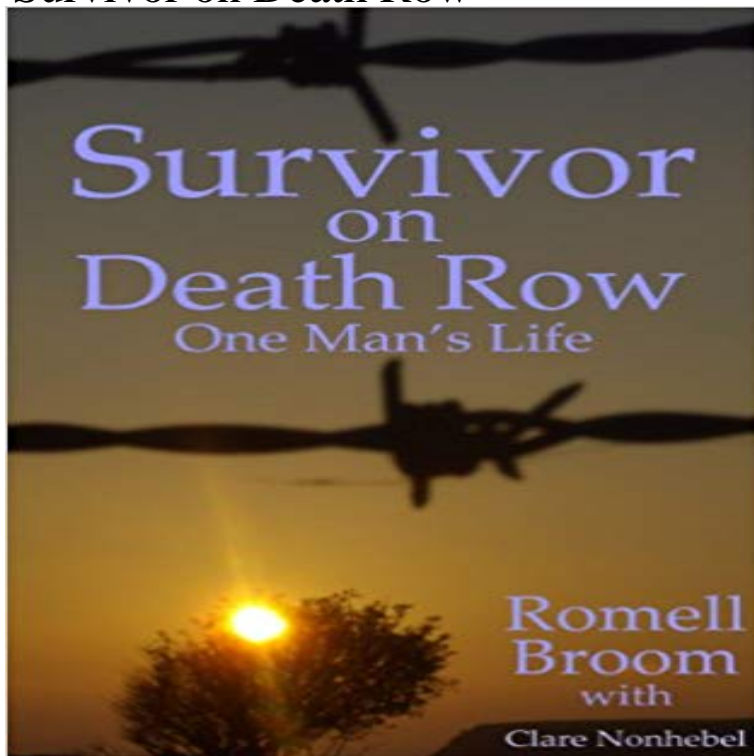


## Survivor on Death Row
